

**WEST VIRGINIA UNIVERSITY
DEPARTMENT OF MILITARY INSTRUCTION
CROSS ENROLLMENT AGREEMENT
WITH
PENNSYLVANIA STATE UNIVERSITY - FAYETTE CAMPUS**

This agreement is made this _____ day of _____, 1996, by and between West Virginia University at Morgantown, West Virginia and Pennsylvania State University - Fayette Campus at Uniontown, Pennsylvania.

WHEREAS, under the provisions of Public Law 88-67, and Section 2102, Title 10, United States Code, a Senior ROTC unit was established at West Virginia University effective March 24, 1965, pursuant to an agreement between the governing authorities of West Virginia University and the United States Department of the Army;

WHEREAS, due to the national reorganization of the Army ROTC program, the California University of Pennsylvania ROTC program, which has served students at Pennsylvania State University - Fayette Campus pursuant to a cross enrollment agreement between those two institutions, has been identified for termination by the Secretary of the Army;

WHEREAS, the Pennsylvania State University - Fayette Campus Army ROTC program will be without support;

WHEREAS, the governing authorities of West Virginia University and Pennsylvania State University - Fayette Campus desire to enter a cross enrollment agreement pursuant to Army Regulation 145-1 whereby courses offered by the West Virginia University Department of Military Instruction shall be made available to qualified students at Pennsylvania State University - Fayette Campus;

NOW, THEREFORE, in consideration of the opportunity to promote the West Virginia University experience among Pennsylvania State University - Fayette Campus students and other valuable consideration, and of the mutual exchange of promises recited herein, the parties hereby agree as follows:

- I. West Virginia University agrees to do the following:
 - a. Authorize the Professor of Military Science to conduct Army ROTC instruction to students enrolled at Pennsylvania State University - Fayette Campus.
 - b. Accept for instruction in military science and enrollment as cadets in West Virginia University Reserve Officers' Training Corps unit any qualified student from Pennsylvania State University - Fayette Campus on the same basis as qualified students who are enrolled at West Virginia University.
 - c. Provide instruction in military science on the campus of West Virginia University to any qualified student enrolled in the Army Reserve Officers' Training Corps unit at Pennsylvania State University - Fayette Campus.

- d. Make available to qualified Pennsylvania State University - Fayette Campus students at least the following number of credit hours of academic instruction in military science:
 - (1) Military Science I -- 1 hour per week
 - (2) Military Science II -- 1 hour per week
 - (3) Military Science III -- 3 hours per week
 - (4) Military Science IV -- 3 hours per week
 - e. In addition to the hours indicated above, provide one hour of leadership laboratory instruction per week per cadet.
 - f. Provide the required military textbooks to students enrolled in military science courses, at no cost to the students.
 - g. Provide uniforms to cadets enrolled in military science, at no cost to the students.
 - h. Ensure that subsistence allowance is provided, in accordance with existing regulations, to Army ROTC cadets as members of the ROTC Advanced Courses conducted by West Virginia University.
 - i. Ensure that tuition and fees are provided to Pennsylvania State University - Fayette Campus, in accordance with existing regulations for Army ROTC cadets on scholarship status, for Pennsylvania State University - Fayette Campus students who are enrolled in Army ROTC courses conducted by West Virginia University.
- II. Pennsylvania State University - Fayette Campus agrees to do the following:
- a. Accept the grades awarded by the Department of Military Science at West Virginia University for inclusion in the students' official grade record and grant appropriate academic credit applicable toward graduation for the successful completion of ROTC courses. Credit hours will be certified to the Pennsylvania State University - Fayette Campus Registrar. The following academic credit hours will be awarded towards a student's degree plan for the indicated military science courses offered at West Virginia University:

- b. Include in appropriate publications, i.e., school catalog/information bulletin, announcement of military science courses available to its students as credited course offerings.
- c. Provide the facilities and space required on its campus during the registration period to accommodate the ROTC staff personnel. Students register at Pennsylvania State University - Fayette Campus for courses offered at West Virginia University.
- d. Appoint one of its staff as an Army ROTC liaison to assist in coordination of Army ROTC activities.

III. It is mutually understood and agreed by the parties as follows:

- a. The Army Reserve Officers' Training Corps program will be administered by the Professor of Military Science at West Virginia University under the direction of the President of West Virginia University and regulations established by the United States Department of the Army.
- b. Two and three-year Army ROTC scholarships are available on an equal competitive basis to freshmen and sophomores of either institution who can qualify. These scholarships pay a maximum of tuition, most fees and a subsistence fee of \$150.00 per month per cadet.
- c. Students at Pennsylvania State University - Fayette Campus contracted as cadets in the Army ROTC program will be subject to the provisions of the Army ROTC Cadet Standards as set forth in Army Regulation 145-1. Failure to meet such standards will be grounds for disenrollment from Army ROTC.

- d. Military Science will not be offered during the summer term.
- e. Pennsylvania State University - Fayette Campus students enrolled in military science courses are responsible for making their own arrangements for transportation to and from West Virginia University for ROTC activities requiring their attendance.
- f. Students auditing military science courses will not participate in field training exercises, be issued or wear uniforms, attend summer camp, or receive credit toward commissioning or enlisted grade status. In the event of a training injury, auditing students are not covered by the workmen's compensation provisions of the Department of Labor.


IV. The following procedures will govern the issuing of Army ROTC uniforms to Pennsylvania State University - Fayette Campus students:

- a. At the expense of the federal government, the Professor of Military Science will issue uniforms, textbooks, and other equipment necessary for the conduct of ROTC instruction to all cadets enrolled in ROTC. Title of issued property remains with the federal government. Cadets are required to return issued property in clean and serviceable condition upon completion of the course of instruction. Each ROTC cadet is required to pay a yearly deposit of \$20.00 to cover any loss or damage to issued property in the cadet's possession. The deposit is paid to West Virginia University's Army ROTC Department. The deposit is refunded, less a nominal yearly administrative and service charge, upon return of undamaged property.
- b. The Department of Military Science at West Virginia University will send out letters requesting uniforms and related items to cadets who fail to turn in Army uniforms at the end of the school year or after dropping out of the Army ROTC program.
- c. Pennsylvania State University - Fayette Campus agrees to withhold the grades of any cadet enrolled in the West Virginia University Army ROTC Program who fails to return any portion of his/her ROTC uniform or equipment.
- d. West Virginia University Army ROTC Department will receive full uniform cost from Pennsylvania State University - Fayette Campus cadets who fail to turn in uniforms or equipment.
- e. Pennsylvania State University - Fayette Campus students must sign a statement acknowledging their receipt and understanding of section 6711 of the Crime Code of Pennsylvania.


- V. The term of this agreement shall commence on _____, 19__, and shall continue until _____, 19__, unless earlier terminated as provided in this agreement. The agreement shall be automatically renewed for one year periods, so long as West Virginia University has sufficient resources available.
- VI. Amendments to or modifications of this agreement may be made upon the written consent of both signatories or their authorized representatives. Either party may terminate this agreement upon sixty days written notice to the other party. However, no modification, amendment or termination shall affect students enrolled for the term in progress or the credit hours to be granted for that term.

The parties hereby execute this Agreement as of the date first above written.
